FIRST AMENDMENT TO THE PROTECTIVE COVENANTS RELATING TO
ROYAL LINKS SUBDIVISION, BLOOMINGTON, ILLINOIS


NOW COMES the Board of the ROYAL LINKS HOMEOWNERS ASSOCIATION after having 2/3 of the voting members approving the amendment to Clause II, paragraph Z as follows:


The entire paragraph Z, in Clause II shall be removed and replaced with the following:

“Z. RECREATIONAL FACILITIES. Any permanent recreational facility, such as a swimming pool or basketball court requires written approval by the Royal Links Architectural Design Committee, or its designated successor. No above ground pools or tennis courts will be permitted under any circumstances.

1. Any basketball goals and backboards and all other outdoor sporting or recreational equipment, must be approved by the Royal Links Architectural Design Committee.
2. All lots will now be permitted to install one basketball goal/hoop/pole, whether of a temporary or permanent design, on their driveway. Permanent in ground pole installation will be pending HOA approval, and within HOA guidelines for placement location on the driveway. Permanent poles must be placed on the outside edge of the driveway nearest to the side yard of the property. JULIE will be notified prior to placement and after Board approval.
3. Temporary, movable designed basketball hoops may now be left on the driveway overnight, if requirements on HOA guidelines on appearance and maintenance are met.
4. It is the homeowner’s responsibility to properly maintain said goal/hoop/pole, to support a positive appearance in the neighborhood.
5. The HOA Board will have the authority to enforce the requirements on maintenance and acceptable appearance of all basketball goals/hoops. If left unaddressed, the Board will have the authority to require removal, as to not create a negative impact on the neighborhood.
6. Backyard basketball hoops will continue to be allowed per existing rules, which exclude rear yards adjacent to the lake.



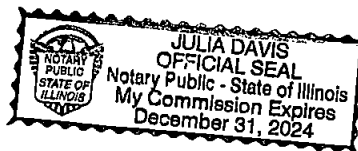


